# **Rules of Competition**

All USAT SANCTIONED events will follow USAT rules, divisions, and scoring for both poomsae and Kyorugi.

- SANCTIONED Poomsae is listed on the next page
- SANCTIONED Kyorugi competitors may use either Gen1 or Gen2 Daedo socks
- SANCTIONED Kyorugi competitors MUST have groin guards (male and female)
- No exhibition matches for the SANCTIONED portion of the event

**OPEN forms will be double-elimination for all belts.** 

• Any form may be performed

### OPEN freestyle poomsae will follow USAT rules with the following exceptions:

- There will be three divisions for males and females:
  - 11 & under; 12-17; 18 & over (color and black belts combined)
- The time limit will be 90-100 seconds

### **OPEN sparring will follow USAT rules with the following exceptions:**

- All Color belt matches will be 3 rounds of 1 minute
- Cadet, Junior, and Senior black belt matches will be 3 rounds of 90 seconds
- Light head contact will be allowed for all divisions
- Full contact will be allowed for 15+ black belts and 18+ all belts
- Red and black belts must have either Gen1 or Gen 2 Daedo socks

Daedo socks may be pre-purchased at <u>www.daedosouth.com</u> (and picked up at the tournament to save shipping) or purchased on site.

No glasses or sport goggles will be allowed during sparring competition.

# Competitors, coaches, or supporters who display poor sportsmanship will be asked to leave.
