I take pride in inviting you to the 2024 Roman Taekwondo Classic to be held on November 9. This year's event will again be held at the Pepperell High School Gym in Lindale, Georgia, just south of Rome.

This year we will be staying with the basics and offer divisions for open double-elimination forms, board breaking, and sparring.

The sparring divisions will use the newest World Taekwondo rules meaning all divisions will fight the best two of three rounds. All divisions will allow head kicks: light contact for all color belts and black belts under 15; full contact for 15 and up black belts. All black belt divisions will use Daedo Gen2 with electronic headgear.

International Referee John Seiber will again be the Referee Chair. All referees will be WT, USAT, or AAU certified.

## **Tournament Information**

The Roman Taekwondo Classic is open to practitioners of all styles of martial arts, any form or breaking pattern may be used for competition; however, sparring competitions will be governed by modified WT/USAT Olympic rules. Competition age will be based on year of birth, the same as WT, PATU, USAT, AAU, and ATU; competitors born on December 31, 2012, will be considered 12 years old for this event.

**Fees:** There are divisions for forms, breaking, and sparring competitions. Registration for forms and/or sparring is: \$110 (through October 13); \$120 (October 14 – November 3).

Registration after November 3 or at the door will be \$160 for two events (cash only at the door).

Additional registration for **color belt** board breaking (includes 3 boards): \$20 Additional registration for **black belt** board breaking (includes 5 boards): \$30

No refunds will be given for paid registration.

#### If paper registration is used, it must be postmarked by October 28.

**Coaches:** Coaches Passes are \$20. No one will be allowed to coach without a pass. School owners, you will not be charged a coach's fee to support your athletes at our tournament. Please contact Master Bradley with your school information, the number of athletes you're bringing, and the number of passes that you will need.

**Check-in:** Check-in will open at 7:30am. No entries will be permitted into divisions that have already begun. *All competitors may be required to weigh-in (in uniform) when called to holding.*

# **Rules of Competition**

#### Forms will be double-elimination for all belts.

- Any traditional empty-hand form may be performed
- Contestants may switch forms at each round
- Contestants may not restart a form unless both contestants fail to finish the first time

#### Breaking rules will be as follows:

- Contestants may perform any combination of breaking techniques, but all routines must include at least one kicking technique and one hand technique
- All contestants will have 3 minutes to set-up, perform the breaks, and clean up
- Color belts will have three boards (included with breaking registration)
- Black belts will have five boards (included with breaking registration)
- No breaking with the head will be allowed
- No props or mechanical holders will be allowed
- No speed breaks will be allowed; all boards must be held with two hands
- Competitors must supply their own board holders
- One attempt to break all boards will result in 1<sup>st</sup> place
- Two attempts to break all boards will result in 2<sup>nd</sup> place
- Three or four attempts to break all boards will result in 3<sup>rd</sup> place
- More than four attempts to break all boards will result in disqualification

#### Sparring will follow WT/USAT rules with a few modifications:

- All matches will be decided by the best 2 out of 3 rounds
- All Color belt matches will be 1-minute rounds
- 14 and under black belt matches will be 90-second rounds
- 15 and over black belts will be 2-minute rounds
- Light head contact will be allowed for all divisions
- Full contact will be allowed for 15 and over black belts
- Black belts will compete with Gen2 chest pad with electronic headgear
- All sparring competitors must have their own mouthpiece, shin/instep, forearm, blue & red chest protector and white (or blue & red) headgear; chest and head will be provided for black belt divisions. All male competitors must wear groin protection; it is recommended that females also wear groin protection. Black Belts must have gloves and their own Daedo socks (Gen2 is recommended).

Daedo socks may be pre-purchased at <a href="www.daedosouth.com">www.daedosouth.com</a> (and picked up at the tournament to save shipping) or purchased on site.



No glasses or sport goggles will be allowed during sparring competitions.

Competitors, coaches, or supporters who display poor sportsmanship or abusive behavior will be asked to leave.
